Special Hazard

Incomplete combustion and thermolysis may produce gases of varying toxicity such as carbon monoxide, carbon dioxide, various hydrocarbons, aldehydes and soot. These may be highly dangerous if inhaled in confined spaces or at high concentration. Combustion products include sulphur oxides (SO₂ and SO₃) and Hydrogen sulphide H₂S, Nitrogen oxides (NO_x), Phosphorous oxides.

Prevention of fire and explosion	Take precautionary measures against static discharges. Ground/bond containers, tanks and transfer/receiving equipment.
